OWNER AGREES TO: Provide all utilities, Vonage internet telephone (has bad or no connection at times), kitchen equipment, linens and towels. OWNER will also provide a care-taker (onsite or offsite) for help if problems occur and will do our best to help as soon as possible or reasonable.

RENTER AGREES TO: Conserve water and electric. Problems may occur due to over usage and not turning off unused electrical power. Renter will also leave the premises in the same order as found; to return keys to OWNER/AGENT on departure and not to exceed the maximum people for sleeping accommodations provided. The damage deposit will not be returned until the premises have been inspected following the RENTERS departure. If more than the agreed upon number of people are found to occupy the premises, or excessive clean up is required additional charges for linens and maid service will be levied against the RENTER and deducted from the Damage Deposit. Such determination will be made at the discretion of the OWNER/AGENT. The Damage Deposit plus reasonable costs of collection including attorney fees, if necessary to collect the same. Guests of the RENTER will be the responsibility of the RENTER.
